KSCPM Board Meeting Minutes July 14, 2015 Eastern Kentucky University Richmond, KY The KSCPM Board meeting was held on Tuesday, July 14, 2015, following the Summer Luncheon at 11:30 at the Department of Criminal Justice Training, Funderburk Building, Law Enforcement Complex, Eastern Kentucky University located at Kit Carson Drive in Richmond, Kentucky.

<u>CALL TO ORDER</u>: Jennifer Woods called the meeting to order.

PRESENTATION OF MINUTES: Debbie Fisher had previously e-mailed everyone the minutes from the last board meeting that was held on May 13, 2015, for review. Robinil Jameson made the motion to accept, Margaret Puckett seconded, and the minutes stand approved.

TREASURER'S REPORT: Robinil Jameson handed out the Treasurer's Report dated July 14, 2015. Beginning balance as of 3/19/15 was \$5,694.81 with ending balance as of 7/14/15 was \$7,742.61. All the bills have been paid and all fees have been collected associated with our Seminar and the net income is \$1,841.31. We received notification from the IRS that they have received our application and \$400 fee and we should hear something in 180 days. Larry Totten helped review the application before it was sent. The Treasurer's Report will be filed for financial review.

Trademark Update: We have received conditional approval from the Consortium to use the CPM trademark. We are waiting on the IRS application to be approved. Until that time, we are allowed to keep using the trademark.

<u>ADJOURNMENT</u>: Debbie Fisher made the motion, Eric Garner seconded, and the meeting was adjourned.
