The little things we now take for granted such as attendee gifts for seminars and decorating for society events began when she served as a Program Chair. Many of us still remember her bringing evergreens and gardening scissors to decorate for an Annual meeting. The current

Larry Totten Receives Leadership Award

The Gene Childress Leadership Award was presented to Larry Totten at the Kentucky Society of Certified Public Managers® (KSCPM) Election and Awards Luncheon at the Kentucky Higher Education Assistance Authority Building in Frankfort. The award recognizes outstanding leadership in government, excellence as a role model, exceptional level of service to the public, and performance above and beyond the call of duty.

Larry is an outstanding leader in many areas and his professionalism was also manifested in the high level of active service to CPM organizations at both the state and national levels. This has been well documented since his certification was earned in December 1993. He was the recipient of the 2004 Henning Award. Named after Dr. Kenneth Henning, "Father of the CPM Program," it is the highest honor the AACPM bestows on a member for career accomplishments, community service, and contributions to state and national public manager organizations

In June of 2016, the Bluegrass West Chapter of the Kentucky Public Retirees awarded him the Harry Lee Waterfield Achievement Award. This award is presented to a former public servant who has demonstrated outstanding leadership to the Kentucky Public Retirees (KPR).

As current and retired state employees, retirement and pension benefits are upmost on the minds of all. Modeling his lifelong commitment to service to employees and retirees, since 2013 he has attended every Kentucky Retirement Systems Board and Committee meetings and attended Public Pension Oversight Board meetings,

He also serves as the KPR Legislative Liaison to the Kentucky Retirement System Board and the statewide Legislative Chair and attends legislative committee meetings where bills concerning Pension Issues are discussed.


