KSCPM Board Meeting Minutes June 4, 2013 Environmental Protection Cabinet Conference Room 300 Fair Oaks Drive, Frankfort, KY

The KSCPM board meeting was held on June 4, 2013 at the Environmental Protection Cabinet conference room. Cassidy Connell, President, called the meeting to order at 10:15 A.M.

Those attending included: Cassidy Connell, Larry Totten, Toni Simmons, Debbie Fisher, Margaret Puckett, Robinil Jameson and Jennifer Woods.

Presentation of Minutes: Minutes were provided for the April 9, 2013 meeting. After review, Larry Totten made a motion to approve the minutes and Margaret Puckett seconded the motion. The motion carried.

Treasurer's Report: Margaret Puckett provided The Financial Statement indicating that the Spring Seminar provide income of \$771.38. Currently there are two CD's at \$2,148.19 and \$2,233.30. The current ending balance of the checking account stands at \$5,404.98. A motion was made by Debbie Fisher to accept the financial statement as provided and was seconded by Toni Simmons. The motion carried.

Committee Reports:

Election Committee: Nothing to report at this time. Membership Committee: Debbie Fisher, Program Chair, reported that according to her records we should have approximately 17 members. ASPA has not yet provided the quarterly report updating our membership list. Debbie advised that our society has not received payment for our society's share of the membership dues from ASPA. There has also been a delay in new members receiving emails or membership certifications regarding their enrollment.

Program Committee: Toni Simmons, Program Chair, advised that the Spring Seminar was a success with 29 attendees (including speakers). She informed that the Summer Meeting is scheduled for July 24th at the Criminal Justice Training Center in Richmond, Kentucky. She has requested that members recommend possible speakers.

Toni also advised that the winter meeting/banquet will be held on December 11th at Berry Hill Mansion, Frankfort, Kentucky. Additional information will follow regarding this event.

Toni requested the board consider a recent issue regarding the Spring Seminar in which an individual's agency paid for registration but did not attend. This individual advised that she simply forgot to attend and was asking that she be provided with a credit to a future event. Discussion was held among the board regarding the past policy to not provide refunds or credit as expenses (such as meals) are based upon the number of attendees. A motion was not made to change the current standing policy.

Finance Committee: Nothing additional to report at this time.

Publications & Publicity Committee: Larry Totten informed members that the Newsletter was being developed at this time and would include notification of the July 24th Summer Luncheon. He requested that any pictures from the Spring Seminar be forwarded to him. He stated that he would also try to include any updates from ASPA and any local meeting dates/locations for members who may wish to attend. He stated that he will need any articles or information from members no later than June 21st to include in the upcoming newsletter.

Awards Committee: Robinil H. Jameson reported that other than the Henning Award nomination, there was no other information to provide at this time. President Cassidy Connell advised that the Society's nomination of Ande Godsey had been completed and mailed before the deadline.

Legislative Committee: Nothing to report at this time.

GSC Update: Cassidy Connell, President, informed that there is no additional information to provide at this time. They are still waiting for KSU to develop the CPM program.

New Business: Discussion was held regarding the AACPM meeting in Boise, Idaho and the need to send the names in of our delegates. As stated in the bylaws, the current president and vice president elect shall act as delegates when possible. Both Cassidy Connell and Sallie Razor plan to attend. A motion was then made by Robinil Jameson to send Jennifer Woods as the third delegate with the understanding that if her agency did not fund the trip, the society would pay for the expenses. Margaret Puckett seconded the motion and the motion carried.

Discuss was then held regarding sending a Kentucky basket, as done in the past, for a raffle at the national conference. Discussion was held as to whether there would be a basket raffle held, as this may be the last year for the national conference. Jennifer Woods made a motion that the Society agree to spend \$150 on a basket (as done in the past) if the traditional raffle is held at the national conference. Robinil Jameson seconded the motion. Motion carried.

Discussion was held regarding the future of the society based upon the decline in membership. Larry Totten informed that several states are experiencing the same problem. He stated that Kentucky should be scheduled for reaccreditation next year and this may be a problem if the program is not active. Hopefully, KSU will send someone to attend the consortium meeting at the national conference in September. It was agreed that the Kentucky Society will continue to promote the program and strive to remain relevant, while hoping that the CPM program will become active in the near future.

Robinil Jameson made a motion to adjourn; Larry Totten seconded the motion; motion carried. The meeting was adjourned.

KSCPM Board Meeting Minutes April 9, 2013 Dept. of Alcoholic Beverage Control Conference Room Frankfort, KY

The KSCPM board meeting was held on April 9, 2013 at the Department of Alcoholic Beverage Control conference room. Cassidy Connell, President, called the meeting to order at 11:30 A.M. After welcoming those attending, Cassidy provided a copy of the KSCPM 2013 Calendar.

Those attending included: Cassidy Connell, Ande Godsey, Larry Totten, Toni Simmons, Debbie Fisher, Sallie Razor and Greg Giesler and Jennifer Woods.

Presentation of Minutes: Minutes were provided for the January 30, 2013 meeting. After review, Greg Giesler made a motion to approve the minutes and Ande Godsey seconded the motion. The motion carried.

Treasurer's Report: Cassidy Connell, on behalf of Margaret Puckett, Treasurer, provided the Financial Statement indicating a beginning balance as of 1/1/2013 of \$5,214.02. Recent expenses included the room rental at the History Center in the sum of \$640.00 for the May Conference. The current ending balance is \$4,460.81. A motion was made by Jennifer Woods to accept the financial statement as provided and was seconded by Ande Godsey. The motion carried.

Committee Reports:

Election Committee: Nothing to report at this time. Membership Committee: Debbie Fisher, Program Chair, reported that ASPA provides guarterly updates and forwards appropriated funds as designated to AACPM and KSCPM. She stated that the online registration process is very difficult. Three members have been confirmed as completing their dues with other applicants most likely being processed. Debbie stated that she had inquired about membership cards and was advised that ASPA sends out membership certificates. She informed that a teleconference was scheduled on this date to discuss membership documents. Early enrollment deadlines have also been extended as initially established to be one year for new Total dues paid by a member are ASPA members. established for this year at \$120.00 to be mailed and processed through ASPA. ASPA retains \$79.00 (\$75 for dues and \$4 for administrative fees) and forwards the balance of \$41.00 to AACPM. AACPM retains \$16.00 and forwards the remainder of \$25.00 to KSCPM.

Program Committee: Toni Simmons, Program Chair, stated that her committee has been working to make plans for the May 2013 KSCPM Spring Conference. This

event will be held on May 22, 2013 (8:30 a.m. to 3:30 pm) at the History Center, Frankfort, Ky. The theme is "Honoring the Past, Treasuring the Present and Shaping the Future." Speakers will include Dr. Edward T. Jennings of the Martin School of Public Policy and Administration from the University of Kentucky; Sharon Marcum, Organizational Development Consultant and retired Executive Director from Governmental Service Center; and Beth Gordon, Performance Consultant, from the Personnel Cabinet. Door prizes will be distributed throughout the conference. Lunch will be provided by the All The Way Shop. As done in the past, participants may take a self-guided tour of the History Museum.

Toni informed that they are also planning the summer meeting to be held on July 24th at the Department of Criminal Justice Training Center at Richmond, Ky. The fall awards banquet is planned for December 11th at the Berry Hill Mansion, Frankfort, Kentucky. Additional information will follow regarding both events.

Finance Committee: Nothing additional to report at this time.

Publications & Publicity Committee: Larry Totten informed members that the Newsletter had been completed and distributed. He stated that he plans to also include additional information in the future regarding ASPA. Larry also stated that there had been past discussions regarding updating the design of the website. To keep the costs to a minimum, the only modifications at this time are to include the ASPA text and link.

Awards Committee: Jennifer Woods reported on behalf of Robinil H. Jameson, who was unable to attend. Jennifer informed that the original trophy provided for the Gene Childress award was no longer available. After a great deal of research, a comparable trophy would be Product GG28 from Capital City Trophy. The recommended trophy has a similar visual design but is made with a dark wood finish versus metal. Photos of the trophies were provided. Larry Totten made a motion to approve using this trophy for the Gene Childress Award and Greg Giesler seconded the motion. The motion carried.

Jennifer also advised that the Society is seeking nominations for the Henning Award which is due by May 25th. Nominations should be forwarded as soon as possible to Robinil Jameson.

Legislative Committee: Nothing to report at this time.

GSC Update: Cassidy Connell, President, informed that there is nothing to provide at this time.

New Business: Discussion was held regarding dues and registration to the Spring Conference. As done in the past, attendees may submit their organization dues along with registration when the costs are being paid by the

employer. However, the Society must ensure that the dues are forwarded to ASPA for appropriate processing and distribution. Members who must pay their own dues should continue to forward to ASPA.

Discuss was held regarding appointment of delegates to the AACPM Conference to be held in September. The ability to pay for registration and costs of delegates by the Society will hinge on the financial success of the Spring Conference. This issue was tabled until after the Spring Conference.

Sallie Razor made a motion to adjourn; Greg Giesler seconded the motion; motion carried. The meeting was adjourned.

2013 KSCPM PROFESSIONAL SEMINAR

"Honoring the Past, Treasuring the Present, Shaping the Future"

The annual KSCPM professional seminar was held on May 22nd at the Kentucky History Center in Frankfort, KY. This year's theme, "Honoring the Past, Treasuring the Present, Shaping the Future" was highly appropriate as the information provided was applicable to changes currently being experienced within the KSCPM, and in a majority of our agencies.

After a welcome by this year's Society President, Cassidy Connell, an overview of the history of the Society was given by long-time member and former KSCPM and AACPM President, Larry Totten. Larry provided information regarding the beginnings of the Society and highlighted various changes throughout its history.

Next, Dr. Edward Jennings, former ASPA President, and current director of the International Programs and Ph. D. Program with the Martin School of Public Policy and Administration at the University of Kentucky, highlighted the "treasure" and/or opportunity that we all have now with the recent affiliation to ASPA; to join and become members in ASPA, AACPM and KSCPM for one fee. Dr. Jennings reviewed the multiples benefits of joining ASPA and shared his experiences throughout the years since becoming a member of the organization.

In relation to change, Sharon Marcum, Organizational Development Consultant and retired Executive Director of the Governmental Services Center, provided a highlight on Strategic Planning. The session focused on the purpose, product and process associated with strategic planning. In addition, a strategic planning model was explained, along with an emphasis on the core values, mission and vision of an organization. Attendees were provided information regarding situation analysis and ended the session reviewing keys to successfully implementing a strategic plan.

The afternoon program consisted of two sessions on Change Management, provided by Beth Gordon, Performance Consultant with the Governmental Service Center. Attendees received information on how to understand change and the transition process, how to effectively guide others through transition, practiced personal resilience strategies, and identified proactive behavior choices. The session was highly interactive and even required attendees to play a game in which they had to "think outside of the box/square".



In addition to the various sessions, attendees had time to tour the exhibits at the History Center and the various booths in the reception area. We would like to thank the following organizations for sitting up a booth and providing us with information and/or door prizes throughout the day. 
