

Our next board meeting is scheduled for April 24th and our KSCPM Spring Conference is May 8th.

We have much work to be done this year and we need everyone's help. I look forward to working with all of you in an effort to preserve and protect our society. This year we must not only envision our future but we must pursue it.

Board Minutes January 9, 2014

The KSCPM board meeting was held on January 9, 2014, at the Office of the Attorney General, 1024 Capital Center Drive, Suite 200, Frankfort, Kentucky 40601 in Conference Room A.

Sallie Razor, President, called the meeting to order at 3:36 pm and asked if there was a quorum present and there was.

Those attending included: Sallie Razor, Cassidy Connell, Debbie Fisher, Ande Godsey, Robinil Jameson, Mary Pascal, Toni Simmons, and Jennifer Woods.

Presentation of Minutes: Jennifer Woods, the previous Secretary, said the minutes from the last meeting had already been approved and printed in the last Newsletter.

Treasurer's Report: Margaret Puckett, the previous Treasurer, wasn't there but the new Treasurer, Robinil Jameson, was there and she handed out a summary sheet of the Treasurer's Report. The checking account balance as of January 9, 2014, is \$5,021.49. There was a \$25.05 difference due to a redeposit of check #859 which was cashed on December 17, 2013, and \$.05 interest earned. There is one CD, #106790, at \$2,148.26. **Society financial assets total of \$7,169.75.** Robinil stated that if anyone had any personal reimbursements they must be submitted on a KSCPM expense voucher and that Sallie would also be talking about this later in the meeting. Robinil said that Cassidy Connell is now the registered agent with the Secretary of State's Office. The financial documents were not reviewed at the end of 2013 but review will be completed in a week.

Committee Reports:

Finance Committee: 2013 Financial Review.

Publications & Publicity Committee: Sallie Razor handed out a one page 2014 year calendar that listed when different events are to take place and certain items needed to be completed.

New Business: Sallie Razor handed out copies from the Standard Operating Procedures (SOP) Manual of duties and responsibilities to the respective officers and appointed chairs.

Sallie explained that when at all possible prior approval for expenses should be requested before expenses are incurred. If someone foresees an expense, give Robinil or Sallie an estimate first. She handed out a copy of a KSCPM Expense Reimbursement Form and reiterated that this form must be filled out to receive personal reimbursement.

Spring Conference: Toni Simmons will coordinate efforts with Sallie for a day in May to have the seminar at the Attorney General's Office at 1024 Capital Center Drive, Suite 200, Frankfort, Kentucky since that is where Sallie works. Toni will solicit the help of other members for theme and set up.

Sallie Razor stated she received an e-mail from Victoria Gordon who is with the Louisville ASPA Chapter stating their next meeting will be February 4, 2014.

Robinil Jameson stated that she and Margaret Puckett have purged and updated the membership roster.

April 24, 2014, was set for the next board meeting to be held at the same place it was conducted on this date. (Attorney General's Office)

Robinil Jameson made a motion to adjourn; Debbie Fisher seconded the motion; motion carried. The meeting was adjourned.
