Kentucky Society of Certified Public Managers Board Minutes July 8, 2009

The Board meeting was called to order by Past President Tony Smith on July 8, 2009. The meeting was held in Richmond, KY.

The following were in attendance: Tony Smith, Robinil Jameson, Larry Totten, Jennifer Woods, Janice Earnest, and Carmen Bishop. Also in attendance was Jeanne Olivas and guest Kim Rulo, new member of GSC. Tony Smith announced that he has Ande Godsey's voting proxy.

Presentation of Minutes: Secretary Carmen Bishop presented a copy of the April 2, 2009 board minutes for review and approval. Jennifer Woods made a motion to accept the minutes; Robinil Jameson seconded the motion; motion carried.

Treasurer's Report: Treasurer Larry Totten stated that there was approximately \$9,500 in the bank. He did not have the Treasurer's Report but would email it to the attendees. The Treasurer's Report was in fact emailed on

7/9/09. The 7/9/09 Financial Statement shows a checking account balance of \$9,286.50 based on revenue of \$7,977.75 and expenses of \$4,667.18. The KSCPM also has three certificates of deposit at Farmer's Bank, Frankfort, totaling over \$6,000.00. Mr. Totten did state that the certificates of deposit are rolling at very low interest rates.

Committee Reports:

Program Committee: Jennifer Woods stated that she is planning an October luncheon to be held at the Capital Annex with Transportation as a backup location.

Membership Committee: Robinil Jameson stated that there is one new member since the KSCPM Seminar.

Publications & Publicity Committee: Robinil Jameson stated that the next KSCPM newsletter will be prepared after the September AACPM Conference. She stressed the need for the submission of articles, and also suggested that the October luncheon be announced in the newsletter. Tony Smith stated that he would have an Awards Committee article.

Awards Committee: Tony Smith stated that since the GSC projects are now group projects, we need to purchase four additional medallions for the Askew winners. These medallions cost approximately \$65.00 each. Robinil Jameson made a motion to purchase four medallions; Larry Totten seconded the motion. The motion carried with Carmen Bishop opposing the motion. Tony Smith stated that the Henning Award nominee has been taken care of.

GSC Update: Jeanne Olivas stated that GSC was in the process of reviewing the preliminary Accreditation findings.

New Business: Carmen Bishop made a motion for the KSCPM to pay for Jennifer Woods to attend the AACPM Conference if her agency will not pay. Robinil Jameson seconded the motion. The motion carried.

Robinil Jameson made a motion for Larry Totten to take care of obtaining our state basket for the AACPM Conference. Carmen Bishop seconded the motion. The motion carried with Larry Totten abstaining.

Robinil Jameson made a motion to adjourn; Larry Totten seconded the motion; motion carried.

GSC congratulates 19 new Kentucky Certified Public Managers® (KCPM). The newest graduates completed their Capstone projects on August 17 and 18. We also want to thank the sponsors of the most recent Capstone. Group one was sponsored by Tom Cannady, Director of Correction Industries. The group looked at what other states were doing with the correction industries to increase the revenue. Group two worked with Martha Slemp, Branch Manager of Education and Vocational Education to see how other states were doing in this field with budget constraints. Group three worked with David Stumbo (a KCPM graduate 2008) in alternative methods for delivery of OSH education and training. This group looked at mobile training options, on- line training, as well as looking at what other states are currently using to meet the safety education needs. Group IV did a project for Stan Riley (KCPM 2007), Branch Manager of Performance Management. This group surveyed supervisors and employees to see what they need to better utilize the performance evaluation. Each Capstone group did a great job of enhancing the information the sponsors had, and some made recommendations based on the data they collected. The teams were using knowledge, skills, and techniques gained during the two years of workshops and Kentucky State University classes.

The next group to complete the program will begin their Capstone on October 6, and complete the projects on November 10 or 12. Remember, Capstone groups can do projects for any state agency. The teams work for five weeks to complete a project that sponsors would like to do, but don't have either the staff or time. KCPM Status Jerry Pile Governmental Services Center

It had been several years since a comprehensive needs assessment had been conducted in regard to the Kentucky Certified Public Managers® Program. With this in mind, the Governmental Services Center conducted a methodical needs assessment in order to get a "pulse" of the KCPM program. During the summer of 2009, GSC sent out surveys to KCPM current participants and graduates. GSC interviewed focus groups that included leadership in eight different Cabinets throughout KY state government. Also, during this assessment time, the KCPM program was going through reaccreditation. Every five years the CPM program is reviewed by the National CPM Consortium in order to assure compliance with the constitution and by-laws of the consortium. Preliminary results of the reaccredidation visit were taken into account when assessing the survey results.

Analysis of all the results showed that there is work needed in order for the KCPM to, again, be a value to state employees. Several highlighted concerns were raised about the workshops including, but not limited to, the content of those workshops and how they related to current state government needs. There were questions raised about the courses offered by Kentucky State University and if, as structured, they were meeting the need. With these concerns, combined with enrollment showing a pattern of decline over the last several years, it was recommended that we not accept application for Fall 2009. This will give GSC and KSU the opportunity to enter into a "discovery" stage of looking at where we are versus where we need to be. Communication is essential at this time. We are committed to being thorough in our review of the program and working with our partners to make sure the program meets the needs of the participants and the leadership that supports those participants. We will keep our sites updated as new information is available.
