Governor Carroll also talked about his decision to abolish all forms in state government during his tenure to allow for new ideas and new ways to perform day-today activities.

Drug Court Manager Selected as Summer Speaker

Ms. Connie M. Payne, Manager of the Kentucky Drug Court, has agreed to be our summer luncheon speaker.

Ms. Payne joined the Administrative Office of the Courts as the Kentucky Drug Court Manager in March 2003. From March 2003 to May 2004, the Drug Court has grown from 30 employees to 70 employees

encompasses and now 55 counties. Since becoming the Drug Court Manager, she has served on Governor Fletcher's Drug Control Summit, Governor Patton's Drug Policy Workgroup, House Bill 843 Committee, UNITE Board, the Kentucky **ASAP** Board and as Congressperson with the National of Drug Association Professionals (NADCP).

Ms. Payne brings a host of law enforcement and legal experience to this position. For most of her professional career she served as a prosecutor in Fayette County, first as an Assistant County Attorney, and for the past nine Assistant vears as an Commonwealth's Attorney where she specialized in drug, domestic violence, and sexual assault issues. During her time at the Commonwealth's Attornev's Office, she represented the office as the Drug Court representative, co-chair for the Fayette County Sexual Assault Nurse Examiner's Response Team and on the Domestic Violence Prevention Board.

Administrative

The meeting was called to order by President Glenn Thomas. A

correction to the spelling of Pamla Wood's name was noted. A motion to approve the January 28, 2004 minutes was made by Pamla Wood, seconded by Tony Smith, and the motion carried.

Committees

Membership – We now have a total membership of 113. (109 current, 1 renewal, 2 new and 1 associate member coming from GSC.)

<u>Finance</u> – Doug Price said he reviewed the job duties of the Finance Committee and they have complied with all requirements. In addition, the 2003 audit is complete. It was discussed if additional funds needed to be added to the certificate of deposit. Based on the money that will be spent for the 2006 AACPM Conference, it was believed there would be no extra funds added.

Discussion also occurred about switching the KSCPM checking account to an interest-bearing checking account. Robinil Jameson stated the Commonwealth Credit Union may not meet our needs for protection of a corporate account. Doug Price will look into Farmers Bank's interest-bearing checking account policies and minimums.

Election – The timetable is for the Committee to meet in August, prepare ballots in November and members vote in December. Members interested in running for office or serving on the elections committee should contact JoJuana Leavell-Green.

<u>Newsletter</u> - The next newsletter will be published in June. The

deadline for getting information to Glenn Thomas to include in the newsletter is May 14, 2004.

<u>Programs</u> – Guest Speaker selection for the fall professional seminar is complete. There will be five speakers as follows: Rep. Derrick Graham, Sharon Sloan, Rodger Bingham, Glenn Thomas, and Joel Schrader. The Seminar will be September 28, 2004 at the Kentucky History Center, Frankfort. The theme is "<u>Lead</u> and They Will Follow".

Planning for the July luncheon is completed as well. It will be held July 14, 2004 at the Stratton Building in Richmond, KY. The Speaker is Connie Payne. Lunch will be box lunches. There was discussion on the price to charge for the lunch. Jeanne Olivas made a motion to charge \$8.00 for lunch the rest of the year, it was seconded by Carolyn Schaefer, and the motion carried.

<u>GSC report</u> - Jeanne announced that the new staff assistant to GSC is Robinil Jameson.

She then discussed the results of a recent CPM survey that was sent to 503 CPM graduates with 177 responses. The survey consisted of five main topics: CPM Program Value, Competencies, KSCPM Value, Agency Benefits, and Personal Benefits.

Overall among CPM graduates, the image of the CPM program is significantly higher than any of the specific attributes of the program. Among the graduates of the CPM program, the image of high overall value remains strong. The ratings of specific attributes of the program,

however, are significantly lower in almost every case.

Agency support for the program is mixed across the cabinets, but in total is less than desired. Although no direct evidence is available, the suspected loss of upper management support could be a result of circumstances regarding the change in administration and their lack of information about the program.

GSC acknowledged the need to market the program to upper management and educate them about the value the program can have on their supervisors and managers. Currently GSC is developing a strategy to gather information on what agencies feel they need from GSC and then market how GSC can best serve those needs, which includes the CPM program. President Glenn Thomas stated he had sent letters a11 cabinet secretaries to endorsing the program.

Jeanne also stated that some courses are being revised, and that scenario-based case work is being incorporated into the curriculum.

Jeanne then introduced Ann Cobb from North Carolina. She is assessing the CPM Program for re-accreditation, and stated the program would be approved. She then asked the Board members to share with her how the CPM has benefited them individually.

BOOK REVIEW

The *On-Time*, *On-Target Manager*, by Ken Blanchard (The One Minute Manager) and Stephen Gottry (A Kick in the Career), tells the story of Bob the Manager. Bob is a procrastinating 'last minute manager' but doesn't know it. He's been called to a meeting with his company's Chief Executive Officer, Dave.

Bob is pretty confident that he's going to get a new position and a raise. When he arrives late, naturally, what he gets instead is notice that he is on probation for late and shoddy work that has resulted in the loss of a \$200,000 account.

Fortunately, Dave believes that Bob's heart is in the right place and so he sends Bob to meet the new company Chief Effectiveness Officer. This 'CEO' explains that Bob needs to learn the three "P's" of 'The Process' and sets up a series of homework assignments for him to work on as he learns each word.

Just what are the three "P's" that will save Bob's job and turn him into an 'On-Time, On-Task Manager'? According to Blanchard and Covey they are:

Priority
Propriety
Commitment

Confused? So was Bob until the CEO explains that if there actually were three "P" words, chances are that he wouldn't be as likely to remember them as he is with this little 'hook'.

The book is a fast read with some basic but well thought out information about the three words and what they mean to business. Of course Bob learns his lessons and is able to apply this knowledge both in the workplace and at home. Bob is a new man ... and a new manager ... but is that the end of the story? What else is in store for Bob? For that information, you'll have to read the book.

At just over 100 large print pages, this is a one night read that just may have you making a copy of the handy little three "P's" tip card for your desktop.

If you ever find yourself working against a deadline, not because of a lack of time, but because you just keep putting off starting in the first place, this book is definitely for you. The first step is admitting you are a 'last minute manager.' The rest is a matter of reading the book and doing Bob's homework too.
