KSU President Sias Shares Her Dining Room with Members



Dr. Mary Evans Sias, President of Kentucky State University

Dr. Mary Evans Sias, President of Kentucky State University, presented views her on management and what works for her at the Kentucky Society of Managers[®] Certified Public Speaker (KSCPM) Spring Luncheon in Frankfort on March 15.

Dr. Sias is a graduate, summa cum laude, of Tougaloo College and earned an MBA from Abilene Christian College. She received a Master of Science degree and a Ph.D., both in sociology, from the University of Wisconsin. She recently came to Kentucky State University from the University of Texas at Dallas (UTD), where she served as senior vice president for student affairs and external relations. Prior to joining UTD, Sias was chief executive officer of the YWCA of Metropolitan Dallas for 13 years.

Some key points from Dr. Sias' presentation:

- Build teams
- As a new manager, don't start by wiping out everything as soon as you begin your job.

THE CUTTING EDGE First, evaluate who and what you have.

- You don't want a team of people who "look" just like you—it makes for a weak team. You need people who are not afraid to tell you what they think.
- Ask questions—you need feedback.
- Be fair
- Do not make decisions when you are angry.
- Do your homework—know the numbers better than anyone else.
- Don't ask a question unless you already know the answer.
- Never do anything you have to hide.

When it's time for promotions: if no one is ready, you haven't done your job as a manager.

2006 AACPM Conference

In September 2006, the Kentucky Society will host the 18th Annual Professional Development Conference of the American Academy of Certified Public Managers in Louisville at the Galt House. This event will mark the 10-year anniversary from the last time that Kentucky was host. It will also be the 30th anniversary of the establishment of the Certified Public Manager program.

Our theme for the Conference will be "The New Realities – a Decade Later," carrying forward the theme from the '96 event.

While it is still a little early to do much in the way of specific planning, now is the time to encourage our members to volunteer their time toward the successful execution of this event. There's no question that there will be a lot of work to pull this off – the good news is that the more people we have on the job, the easier it will be for everyone.

Job tasks are broken down into five basic committees:

Marketing – This group is charged with the primary responsibility of promoting the Conference. Its main duty is to create and mail the promotional and registration literature sent to Academy members, but other promo activities also fall to this group, such as obtaining giveaway items for door prizes.

Program – This group is responsible for the heart of the Conference: the education program. They will solicit presenters, evaluate responses, and make recommendations. They will negotiate fees and expenses; coordinate A/V needs; obtain CEU credit for the program; and work with presenters during the Conference.

Registration – This group is responsible for keeping track of the Conference registrants and their money. They will be in receipt of registration information prior to the Conference and handle all registration activities on site.

Hospitality – This group is responsible for the social aspects of the Conference, working extensively with the hotel staff. This includes the Conference food functions - Welcoming Reception. Awards Banquet. Presidents Luncheon, breaks and any other planned meals. They will also put together "What to do in Louisville" information that will be given to registrants, and arrange for any outside activities that are planned.

Exhibitors – This group is responsible for soliciting sponsorships for our events and getting exhibitors to display their products. This will be a very challenging committee, as an attempt has been made over the past few years to try to get national vendors interested enough in us to be present at the Conference as it moves around the country.

This will be our basic structure; we will add to these if needed and there will be sub-committees within these larger groups.

This is a very Society-focused activity and we need your participation. I think there is something here for everyone's personal interests and talents. We also need your attendance next year as well. This Conference will replace our own one-day event next fall, so it's never too early to start preparing your boss for that in-state travel request. information will More be forthcoming throughout the year.

COMMITTEE REPORTS

Membership

Helen Koger reported that Membership packets including 2005 ID cards, brochures, pins and directories have been distributed to all members to date. Members "opting out" (electing not have membership to information included in the directory on the AACPM's web site) were not included in the KSCPM directory because the same database is used by both. Records indicated the expenses for last summer's speaker luncheon were \$287.76 and receipts were \$272, which was about \$17 difference. Jack Bates moved that the budget be accepted as amended and that revenue match expenditures. The motion was seconded by Sherman Bowman, Motion carried.

Program

Sherman Bowman reported the Summer Luncheon is scheduled for Monday, July 18 (later changed to July 12) in Richmond. Plans are progressing. Possible speakers include: First Lady Glenna Fletcher, Senator Ed Worley and Representative Harry Moberly.

The KSCPM Seminar is tentatively scheduled for August 16. Program Chair Sherman Bowman will check on reserving the History Center. We are still working on a theme, and presenters.

AACPM Conference

Larry Totten focused attention on the AACPM Conference scheduled for September 18-21, 2005.

It is time to select delegates for the AACPM Conference. The By-laws state the President, President-Elect and one other person may attend. The \$2500 budgeted in the past may not be adequate for conference attendance. The Board decided to

Glenn Thomas requested reimbursement for registration and room only because he will be a paid speaker. Jeanne Olivas seconded the motion. Motion carried.

KSCPM Member Portrait

This month's guest is Carol Etler, who took a few minutes from her responsibilities as Right-of-Way Agent in the District 6 Office (northern Kentucky) of the Transportation Cabinet to speak with us.

Carol Etler isn't always welcomed when she arrives - at a mansion on one day and to a poverty area the next - seeking right-of-ways for the Transportation Cabinet. At a former job with Families and Children, she was a supervisor and also encountered people with diverse disabilities, from different cultures, and sometimes with limited comprehension. In both of these jobs, she understated, "you may have to diffuse people." Given those responsibilities, it is not surprising that she is especially grateful for CPM training that helps her understand personalities. Those "DISCs" have come in handy!

"It is wonderful to learn," Carol said, "and change is constant." Besides appreciating knowledge, she is also dedicated and persistent. Getting her CPM required taking vacation days to attend some of the classes and paying for her own lodging, miles, and meals – and she did all this *before* Certification included a potential salary increase. Yet Carol has no regrets. "I can't say enough good things about the program," she assured me.

While she worked on her Certification, Carol was also pursuing a degree at Northern Kentucky University. Since she was working, raising children, and earning her Public Manager Certification, it took twelve years – so long, in fact, that she found herself in classes with her sons' friends. She finished last year, telling her family and friends, "I'll be darned if I'll go to school with my *grandsons*' friends!" Her degree is in Organizational Systems Technology, with a concentration in social work: "a lot of business and education, computers, and social work," she explained.

Carol found that her CPM and university classes enhanced one another. She admitted that being a non-traditional student has its peculiar challenges; yet she also pointed out that "We can learn so much from the younger people." Not surprisingly, she was not the only one who benefited from her diligence. The 21-and-under college students in Carol's classes told her that they benefited from her experiences. Professors were grateful for training materials she shared with them, from Sexual Harassment and Violence in the Workplace workshops. One professor told her, "Maybe I should have you teaching this." In fact, one of her professors recognized the breadth of her contributions with a successful nomination to the 2002 issue of Who's Who Among Students In American Universities And Colleges.

In addition to diffusing conflict and understanding people, Carol appreciates her CPM training related to understanding and dealing with change, and to team building. As a supervisor, she was better able to involve employees, especially under changing conditions. She used "the upside-down pyramid process," asking employees, THE CUTTING EDGE "What would you do, how would you do it? How would you do it differently?"

Carol has shared her skills outside of state government, as well. She has worked with the Citizens Committee for Foster Children (now the Foster Parent Association), assisted the KY Employees Charitable Campaign for 10 years, and edited a newsletter for Families and Children's Region 9's "Vision 2000."

These days, Carol shares her enthusiasm for learning with her co-workers, encouraging them to get into the CPM program and develop management skills. She encourages young and older workers alike. "You're never too old to learn," she tells them, "and learning can be fun. It can help you do a better job at whatever you are doing." There's a good chance that she is part of the reason that four people from her office received Certification last year, and six are currently candidates.

Although her work and location in Northern Kentucky keep Carol from attending KSCPM events, she has been a member since 1999, and hopes to sign up employees as soon as they graduate. I asked her why she was such a loyal member.

"I want to see the program continue," was her immediate answer. She encourages KSCPM leadership to continue supporting the program, providing postgraduate education, and generally putting out good PR. Carol's been doing a good job on the latter, with her unwavering support among co-workers in her agencies, Northern Kentucky University, her employees, clients, and – yes, even among her sons' college friends.
