#### 2006 AACPM Conference

In September 2006, the Kentucky Society will host the 18th Annual Professional Development Conference of the American Academy of Certified Public Managers in Louisville at the Galt House. This event will mark the 10-year anniversary of the last time Kentucky was host. It will also be the 30<sup>th</sup> anniversary of the establishment of the Certified Public Manager program.

Our theme for the Conference will be "The New Realities – a Decade Later," carrying forward the theme from the '96 event. Now is the time to get going – The good news is that the more people we have on the job, the easier it will be for everyone. There are five basic committees:

**Marketing** – This group is charged with the primary responsibility of promoting the Conference. Its main duty is to create and mail the promotional and registration literature sent to Academy members. Other promo activities also fall to this group, such as obtaining giveaway items for door prizes.

Program \_ This group is responsible for creating the education program. They will solicit presenters. evaluate recomresponses, and make mendations; negotiate fees and expenses; coordinate A/V needs; obtain CEU credit for the program; and work with presenters during the Conference.

**Registration** – This group is responsible for keeping track of the conference registrants and their money. They will be in receipt of registration information prior to the conference and handle all registration activities on site.

**Hospitality** – This group is responsible for the social aspects of the conference, working extensively with the hotel staff. This includes the conference food functions, room setups, and any other hotel issues. Some will put together "What to do in Louisville" information that will be given to registrants and arrange for any outside activities that are planned.

Exhibitors – This group is responsible for soliciting sponsorships for our events and getting exhibitors to display their products. This will be a very challenging committee, as an attempt has been made over the past few years to try to get national vendors interested enough to follow the conference as it moves around the country.

As you can see, there is something here for everyone's personal interests and talents. We also will need your attendance next year as well. This conference will replace our own one-day event next fall, and it's never too early to start preparing your boss for that in-state travel request. More information will be forthcoming throughout the year.

#### 2005 KSCPM PROFESSIONAL SEMINAR

"Leading In Whitewater" By Janice Earnest, CPM

On August 16, the Kentucky History Center in Frankfort was again the location of our annual Professional Seminar. With a theme of "Leading In Whitewater," the presenters covered various ways of leading and managing in times of difficulty.

Commissioner Roy W. Mundy II, Department of Vehicle Regulation of the KY Transportation Cabinet said, "Yesterday's challenge is today's opportunity." He stressed that things go wrong when communication goes wrong and gave some ideas on improving communication: monthly meetings; monthly newsletters; focus groups and an open door policy.

Executive Director Stanford Lampe, KY Education Cabinet, told us, "Crisis communication is an art. It's not for everyone." He listed the "Ten Commandments of Crisis Communication" and stressed that the one thing journalists want is for us to be accessible. They want quick, simple answers. Susan G. Smith, CPM, SPHR, Human Resources Consultant and former president of KSCPM, gave an insightful presentation on "The High Cost of Workplace Stress." She cited stress as the root cause of much of the increase in workplace health care costs and shared causes and symptoms of workplace stress, along with employee retention secrets. Susan urged managers to "Give credit rather than take it and take blame rather than give it."

Sylvia Lovely, Executive Director of the Kentucky League of Cities President of NewCities and Foundation. stated that manv American communities, particularly midsized cities and towns, are shrinking. She shared the "12 Principles of Community Building," which are ways to make America's cities thrive. Managers, to make workplaces flourish, can use many of those same principles such as: Don't merely grow-plan and develop over time; Rethink boundaries; Cultivate leadership and civic involvement: Connect to the world, and Feed the mind and nurture the soul.

During the lunch break, there was time to tour the History Center exhibits or visit the booths in the resource area. Representatives from Deferred Comp, Parks and Recreation, Commonwealth Credit Union, Retirement, Drive Smart, and Kentucky Employee Mediation Program were present and were given a few minutes on the program to explain their functions.

Among the door prizes awarded was a two-night stay at Lake Cumberland State Park, won by Margaret Puckett. Parks and Recreation representative, Robin Caldwell-Welch, generously donated other door prizes of one and

#### IN ATTENDANCE

Larry Totten, Robinil Jameson, Glenn Thomas, Carmen Bishop, Janice Earnest, Helen Koger, Sherman Bowman, Tony Smith, and Pamla Wood.

#### ADMINISTRATION

The Board Meeting was called to order by President Larry Totten and an agenda was presented.

The Board Minutes from the May 19, 2005, June 6, 2005, and July 12, 2005 meetings were reviewed. A motion was made to approve these minutes by Janice Earnest, Carmen Bishop seconded, the motion carried.

#### FINANCIAL REPORT

Robinil Jameson stated that the current balance in the checking account is \$6,910.53. This balance includes \$915.00 that we received from the AACPM 2005 Conference raffles. This money is to be segregated into the 2006 conference account once it is established. In addition, the certificate of deposit is valued at \$2,062.57.

#### **COMMITTEE REPORTS**

<u>Election Committee</u> (Tony Smith) The Elections Committee is preparing a letter to be e-mailed to the membership, seeking nominations for next years' officers and directors. The e-mail should be sent shortly.

<u>Program Committee</u> (Sherman Bowman) The Awards Luncheon is scheduled for December 6, 2005 at the KHEAA Building in Frankfort

from 11:30 until 1:30. Lunch will be catered by All The Way Shop and the menu will be a Holiday Buffet. The registration form for the luncheon is ready to be sent.

Robinil Jameson stated that we need to make an effort to recognize all VIPs that may attend the luncheon.

The Program Committee needs to coordinate with the Awards Committee on obtaining awards.

<u>Publications Committee</u> (Pamla Wood) The next newsletter should be sent by the end of next week (October 21, 2005).

A special election newsletter needs to be prepared and sent before the December 6, 2005 Awards Luncheon that details brief bios of all candidates.

There was discussion that next year there will be a need for a monthly newsletter/update- type correspondence that keeps the membership informed about he upcoming 2006 AACPM Conference.

<u>Membership Committee</u> (Helen Koger) The KSCPM currently has 126 members.

Awards Committee (Glenn Thomas) Robinil Jameson was provided 17 projects. The Awards Committee recommended no more than 8 project winners, and will review the scores to determine a more appropriate cutoff. The final project winners will be recognized at the November 8, 2005 graduation ceremony in the Capitol Rotunda.

<u>Legislative Committee</u> (Tony Smith) The upcoming legislative session should be very interesting as topics include the budget, retirement

system, retirement window, merit system law, 40 hour work week, etc... The Legislative Committee has nothing to report as there have been no pre-filed bills at this time.

#### **NEW BUSINESS**

<u>Graduation Ceremony</u> (Robinil Jameson) The CPM graduation will be in the Capitol Rotunda on November 8, 2005 at 2:00 pm. There will be approximately 34 graduates.The Governor may be in attendance.

Letters to Agency Heads (Tony Smith) Tony recommends that letters once again be sent to Agency heads and constitutional officers, detailing information about the Society.

Website (Larry Totten) The Board needs to consider hiring an outside firm to maintain our website to ensure continuity and consistency. This is especially important given the upcoming 2006 AACPM Conference. Larry obtained a price from Net Gain Internet Services, which maintains the AACPM website. The price would be \$75 a month, or \$900 a year. A motion was made by Pamla Wood to use Net Gain Internet Services unless by October 14, 2005 other information is provided about additional options. The motion was seconded by Robinil Jameson, and the motion carried.

Other New Business (Tony Smith) On October 17, 2005 Personnel Cabinet Secretary Erwin Roberts will hold a meeting for all state government employees at 10:00 a.m. at the Transportation Cabinet office building to discuss the Blue Ribbon Merit Task Force proposed recommendations. All employees are encouraged to attend. **2006 CONFERENCE** (Larry Totten)

Larry Totten handed out the AACPM Policies and Procedures Manual regarding Duties and Responsibilities of the Conference Committee. This information should be kept to provide guidelines for the upcoming Conference. Effective January 2006, the Conference Chair will be Julie Felice.

<u>Co-Chair</u> Larry has asked that there be a co-chair to help him with the upcoming conference. Robinil Jameson volunteered for the position. Larry will contact J.R. Brown to find out if he is also interested in being a Co-Chair. A motion was made by Carmen Bishop to accept Robinil Jameson as Co-Chair pending interest by J. R. Brown. Sherman Bowman seconded the motion, and the motion carried.

Committee Chairs There are five major committees for the Conference as follows: Marketing, Program, Registration, Hospitality, and Exhibitors. Larry would like to have all the Chairs and committee members in place by the end of the year. The Program Committee needs to get underway immediately. Glenn Thomas and Pamla Wood volunteered to serve on this committee. Larry will ask Sharon Marcum to join them, perhaps as Chair. The following summarizes current volunteers for specific committees:

Robinil Jameson stated that we need to consider a reduced rate for retirees to attend the conference. If so, we would be the first to offer such a reduced rate.

Sherman Bowman provided an evaluation summary of the KSCPM Professional Seminar. Overall, the evaluations were good to excellent (scores of 4 and 5).

The next Board Meeting will be held on November 8, 2005 at 10:00 a.m. in Room 338 of the Capitol Annex.

Subsequent to the Board Meeting, Robinil Jameson e-mailed the Financial Report on October 11, 2005.
